

Guidelines for International Clients

- Fill out the required information in the Card-Scan Application and Fingerprint form, and print them on regular paper.
- Have your fingerprints taken on the attached form (or a form having similar layout of fingerprints) by your local police or a fingerprinting agency. The name and address of the agency taking fingerprints need to be mentioned on the fingerprint form, and the officer taking fingerprints needs to sign this form.
- Include clear photocopies of two government issued identification documents (IDs). One must be a photo ID, with clearly visible photo.
- Complete the credit card payment form. If you want to pay via PayPal, please send us a quick email and we will send you a PayPal invoice.
- Send all the completed documents via mail (not-email) or courier to our Card Scan facility, to the address on the check-list. We cannot process scanned copies. For getting police check for US immigration, you would also need to complete the "Privacy Act" form and send the original to our office.
- We will digitize inked fingerprints to encrypted format and transmit them to the RCMP (via secure server).
- The RCMP will process fingerprints and after that they send the results (hard copy) via regular mail. The RCMP do not send the certificate via email or courier.
- Under Privacy Act, the RCMP will mail out the results directly to the applicant. No third party.
- If the applicant was ever charged by the police in Canada, overstayed in Canada or deported from Canada, the RCMP can take up to 120 days or more to send the results.

Once we receive and process your application, we will send you a confirmation email. Please **do not** call us or send us emails to check if we received your documents or not.

Incomplete or missing documents will cause delays in transmission of fingerprints to the RCMP.

Frequently Asked Questions

Can I email you a scanned version of my fingerprints for electronic transmission to the RCMP?

Unfortunately we cannot process scanned version of fingerprints. You would need to send us the original fingerprint form and the other documents, as per the check list, via mail or courier.

How would I know that you have received my documents?

Once we receive your documents and transmit fingerprints to the RCMP, we will send you a confirmation email. <u>There is no need to keep on sending emails to check as to whether we have received your</u> <u>documents or not.</u>

Can I get my fingerprints taken on the form used by the police of the country, I am living in?

Yes you can. Please make sure the fingerprint layout on that form is the same as on the RCMP's form or the FBI's fingerprint card. Please have a look on the sample fingerprint form.

Once you receive my documents, how long will it take to receive the police check from the RCMP?

The RCMP takes 3 to 5 business days to process fingerprints and after that they send out the results **via regular non track-able mail**. If there is a criminal record, the RCMP can take up to 4 months to send the results.

Can RCMP send the police check outside of Canada?

Yes, at no additional cost.

I need the Police Check as soon as possible. Can I request the RCMP to send it to your company and you can then forward to me via courier?

Under Privacy Act, the police check can only be sent directly to the applicant. Not to a third party.

How can I pay for your services?

You can pay by Credit Card (Visa or Master Card only), PayPal, International Money Order or Email transfer. If you want to pay via PayPal, send us a quick message to request a PayPal invoice.

Can my friend or relative pay on my behalf?

Yes they can. You can forward credit card payment form to your friend or family member. They can complete it, sign it and email to us.

How can I check the status of my application?

Once we receive your documents and transmit fingerprints to the RCMP, we will send you a confirmation email. The applicant can inquire about the status of fingerprints submission by sending an email to the RCMP at CCRTIS-SCICTR@rcmp-grc.gc.ca.

Can I print the Fingerprint form emailed by you and get my fingerprints taken on it?

Yes you can.

I have a photocopy of fingerprint form. Can I send it to you for processing?

We cannot process photocopy. You need to send us the original fingerprint form via mail or courier.

Cardscan Application

You can type in your information directly into the forms and print them. You can also print them off and fill them in by hand.


